

PROPOSED PROHIBITION OF THE USE OF A CERTAIN MARK

In terms of section 13 of the Merchandise Marks Act, 1941 (Act 17 of 1941), I hereby give notice that it has been requested by the Ministry of Trade and Industry to

prohibit, under section 15(1) of the said Act, the use by any person other than the said Ministry, of the mark shown in connection with any trade, business, profession or occupation or in connection with a trade mark, mark or trade description applied to goods:



The above-mentioned mark shall lie open to inspection at the office of the Permanent Secretary: Trade and Industry, Section: Trade Marks, Trust Centre, Independence Avenue, Windhoek.
