APPLICATION THAT A PORTION OF FARM ROAD 1213 BE CLOSED: DISTRICT OF MARIENTAL

In terms of section 16(3) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that application has been made to the Chairman of the Roads Board of Mariental that the portion of farm road 1213 described in the Schedule and shown on sketch-map P1519 by the symbols A-B, be closed.

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the road to which the application refers and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days, mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendent, Mariental, during normal office hours.

NOMINATION OF CANDIDATES FOR THE ELECTION OF MEMBERS OF THE COUNCIL

Notice is hereby given in terms of regulation 3 of the Regulations relating to Veterinary and Para-Veterinary Professions promulgated by Government Notice No. AG 76 in Official Gazette 5042 of 17 May 1985, that I await nominations of candidates for the election of two (2) members of the South West Africa Veterinary Council referred to in section 5(1)(b) and (c) of the Veterinary and Para-Veterinary Proclamation, 1984 (Proclamation AG. 14 of 1984). The nomination day shall be the 28th day after date thereof.

REMARKS:

The election arises from the expiration of the periods of office of the Council of Drs. H.H.P.A. Schneider and R.H. Hassel on 31 July 1993. Nominations are therefore awaited for the filling of the two (2) vacancies which would otherwise exist on the Council as from 1 August 1993. The said members are eligible for re-election and may be nominated if they are willing to serve on the Council for a further term.

Each enfranchised voter is entitled to nominate two (2) candidates. Nomination of candidates shall be in the form set out in Annexure A of the said Regulations and shall be lodged with me before 16:00 on nomination day. A separate form is to be used for the nomination of each candidate. Each such form has to be duly completed and shall be signed by both the person who is nominated as a candidate and the two persons by whom he is nominated. For the convenience of enfranchised voters forms are also obtainable from me.
