NOTICE IN TERMS OF SECTION 13 OF THE APPRENTICESHIP ORDINANCE, 1938

Under the powers vested in me by section 13(1) of the Apprenticeship Ordinance, 1938 (Ordinance 12 of 1938), I hereby further amend the conditions of apprenticeship prescribed by paragraph (c) of Government Notice R.2473 of 1973 by -

(a) the substitution for subclause (1) of clause 3 of the following subclause:

“(1) An employer shall remunerate an apprentice at not less than the rates specified below:

(a) <i>In trades in the Hairdressing Industry</i>	<i>Per month</i>
First year	R300,00
Second year	R450,00
Third year	R505,00
(b) <i>In three-year trades in other trades than the Hairdressing Industry</i>	<i>Per month</i>
First year	R476,00
Second year	R679,00
Third year	R906,00

<i>(c) In four-year trades</i>	<i>Per month</i>
First year	R476,00
Second year	R566,00
Third year	R679,00
Fourth year	R906,00".

(b) the substitution for subclause (4) of clause 8 of the following subclause:

“(4) A fee of R60,00 shall be payable by an apprentice in respect of the second or any subsequent trade test undertaken in terms of this clause.”.
