GENERAL ELECTION FOR ELECTION OF MEMBERS OF THE NATIONAL ASSEMBLY: NOTIFICATION OF LAST DAY AND PLACE FOR SUBMISSION OF LISTS OF NOMINATED CANDIDATES BY POLITICAL PARTIES AND POLLING DAYS

In respect of the general election for the election of members of the National Assembly pursuant to Article 46 of the Namibian Constitution, read with section 49(1)(b)(i) of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known, under the powers vested in me by section 50(1)(a) and (b) of that Act, that I have determined-

- (a) Tuesday 26 October 1999 as the last day on which political parties that intend to participate in the election for members of the National Assembly shall submit, and not later than 11:00 on that day, a list of their nominated candidates in terms of section 59(1) of the Electoral Act, 1992 to the Electoral Commission at the office of the Director of Elections, Directorate of Elections, Parsival Street, Windhoek; and

- (b) Tuesday 30 November 1999 and Wednesday 1 December 1999 as the days on which a poll shall be taken at the election of members of the National Assembly.

**GENERAL ELECTION FOR ELECTION OF THE PRESIDENT:
NOTIFICATION OF DAY AND PLACE FOR SUBMISSION OF NOMINATIONS
OF CANDIDATES FOR ELECTION AND POLLING DAYS**

In respect of the general election for the election of the President pursuant to Article 28 of the Namibian Constitution, read with section 49(1)(a)(i) of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known, under the powers vested in me by section 50(1)(a) and (b) of that Act, that I have determined-

- (a) Tuesday 26 October 1999 as the date on which the submission of nominations of candidates for election as President shall take place at a public sitting to be held by the Chairperson of the Electoral Commission at the High Court, Windhoek in terms of sections 55(1) and 56 of the Electoral Act, 1992; and
- (b) Tuesday 30 November 1999 and Wednesday 1 December 1999 as the days upon which a poll shall be taken at the election of the President.
