SCHEDULE

DESCRIPTION OF BOUNDARIES OF THE DOROS !NAWAS CONSERVANCY SITUATED IN THE KUNENE REGION

The Conservancy consists of two areas, namely Area 1 and Area 2.

Area 1

The point of beginning is the Skeleton Coast Park border where the Huab River intersects the said park.

The point of beginning in a north-eastern direction following the Huab River to a point of intersection with the south-western corner of the farm Krone 721; thence in a north-eastern direction, excluding the farms Krone 721 and Mikberg 274; thence in a northern direction following the boundaries of the farm Rendevous 533, including the said farm, to the north-western corner of farm 741 (no name); thence in a generally southern direction, excluding farms 741 (no name) and Draaihoek 527; thence to the south-eastern corner of Draaihoek 527 along the western boundary of Vegkop 528 and farm 532 (no name) to a point where the Ugab River intersects farm 532 (no name); thence following the centre of the Ugab River in a western direction up to where it intersects with the Skeleton Coast Park, and then in a northern direction following the Skeleton Coast Park boundary to the point of beginning.

Area 2

The point of beginning is the north-western corner of the farm Bloukrans 512.

From the point of beginning in a generally north-eastern direction, including farms Bloukrans 512, Naauwpoort 511, farm 485 (no name) and Oas 486; thence in a south-eastern direction, including farms Bloemhof 484, Bella Vista 483, Belmont 392 and Welbedacht 394; thence following the southern boundary of Moreson 496 in a western direction, including the farms Langberg 497, Morewag 480, Bankfontein 523, Granietkop 522 and Witwatersrand 521; thence following the western boundary of Witwatersrand 521 up to point No. 850; thence in a northern direction, including farms Malansrus 519 and Driekrone 516, and then to the point of beginning.

Excluded from Area 2 are the area known as Petrified Forest and certain pieces of land, which are subject to a permission to occupy (PTO), in the names of Gotfried Uiseb and Thomas Taniseb.
