#### PROCEDURE FOR ADVERTISING IN THE GOVERNMENT GAZETTE OF THE REPUBLIC OF NAMIBIA

1. The *Government Gazette* (Estates) containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, this *Government Gazette* is published on the preceding Thursday.

2. Advertisements for publication in the *Government Gazette* (Estates) must be addressed to the Government Gazette Office, P.B. 13302, Windhoek, or be delivered at Justitia Building, Independence Avenue, Second Floor, Room 219, Windhoek, not later than 15:00 on the ninth working day before the date of publication of this *Government Gazette* in which the advertisement is to be inserted.

3. Advertisements are published in this *Government Gazette* for the benefit of the public and must be furnished in English by the advertiser or his agent.

4. Only legal advertisements shall be accepted for publication in the *Government Gazette* (Estates) and are subject to the approval of the Permanent Secretary, Ministry of Justice, who may refuse the acceptance of further publication of any advertisement.

5. The Ministry of Justice reserves the right to edit and revise copy and to delete therefrom any superfluous detail.

6. Advertisements must as far as possible be typewritten. The manuscript of advertisements must be written on one side of the paper only and all proper nouns plainly inscribed. ## **B. Nature of the Scheme**

The parties have entered into a combination of transactions which together constitute a scheme for the purposes of the demutualisation of the Society ("the scheme"). The demutualisation of the Society will be effected as part of an overall restructure of the Society and its various corporate holdings internationally.

The scheme is designed to ensure that the rights and reasonable benefit expectations of policyholders of the Society are fully protected while, insofar as the law of relevant jurisdictions permits, qualifying members are able, by an equitable allocation of shares free of charge, to become shareholders in a new holding company (Old Mutual plc) owning through subsidiaries the entire beneficial interest in the restructured group. Free shares will also be issued to eligible employees and certain retired employees as well as to charitable Foundations to promote the interests of the Old Mutual Group.

It is intended that Old Mutual plc, a company incorporated under the laws of the United Kingdom, will in due course be listed on the London, Johannesburg and other stock exchanges.

Key features of the scheme are:

### *1. Conversion of the Society to a company*

The Society will be converted from a mutual life insurance company incorporated in terms of the South African Mutual Life Assurance Society (Private) Act, No. 52 of 1966 (as amended), into a public company having a share capital and incorporated under the Companies Act, No. 61 of 1973. It is proposed to name this company Old Mutual Life Assurance Company (South Africa) Limited ("Old Mutual Life").

### *2. Changes in organisation*

The Society's life assurance businesses in Bermuda, Malawi, Namibia, South Africa and Zimbabwe will in future be conducted by an Old Mutual life assurance company in each of these territories. Other than in the case of South Africa, this will entail the transfer of the relevant life assurance business to the company concerned. In South Africa the same object will be achieved by converting the Society to a company. The Guernsey and Hong Kong life assurance businesses will remain branches of this company after conversion.

Assets surplus to the reasonable requirements of the life assurance businesses, as certified by the Chief Actuary, will be transferred (except in the case of Bermuda) to wholly-owned holding companies within the Old Mutual Group.

The shares in Old Mutual plc, the holding company at the head of the Group, will be issued free of charge and will be entirely separate from, and in addition to, the policies.
