#### REGIONAL COUNCILS ACT, 1992: DETERMINATION OF DATE OF BY-ELECTIONS IN WANAHEDE CONSTITUENCY, KHOMAS REGION AND WALVIS BAY URBAN CONSTITUENCY, ERONGO REGION

Under the powers vested in me by section 10(3) of the Regional Councils Act, 1992 (Act No. 22 of 1992), I hereby determine 24 June 1999 as the date for the holding of a by-election -

- (a) in the Wanheda Constituency in the Khomas Region; and
- (b) in the Walvis Bay Urban Constituency in the Erongo Region;

for the election of a person as member of the regional council concerned to fill a casual vacancy in that regional council.

**BY-ELECTION OF REGIONAL COUNCIL MEMBERS IN WANAHEDA  
CONSTITUENCY, KHOMAS REGION AND WALVIS BAY URBAN  
CONSTITUENCY, ERONGO REGION: NOTIFICATION OF DATE AND PLACE  
FOR SUBMISSION OF NOMINATION OF CANDIDATES, POLLING DAY AND  
OF NAMES OF RETURNING OFFICERS**

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby made known -

- (a) that I have under paragraph (a) of that subsection determined -
  - (i) Thursday 20 May 1999 as the day on which public sittings shall be held for the submission of nominations of candidates for election as a member of the regional council in respect of -
    - (aa) the Wanaheda Constituency in the Khomas Region; and
    - (bb) the Walvis Bay Urban Constituency in the Erongo Region; and
  - (ii) that the said public sittings shall be held from 9:00 until 11:00 at the following places:
    - (aa) in respect of the Wanaheda Constituency, at the Wanaheda Clinic, Independence Avenue, Windhoek; and
    - (bb) in respect of the Walvis Bay Urban Constituency, at the Library Hall, Walvis Bay; and
- (b) that the following persons have been appointed in terms of section 51 of the Act as returning officers at the elections in the constituencies concerned:
  - (i) in respect of the Wanaheda Constituency:

  - (ii) in respect of the Walvis Bay Urban Constituency:
