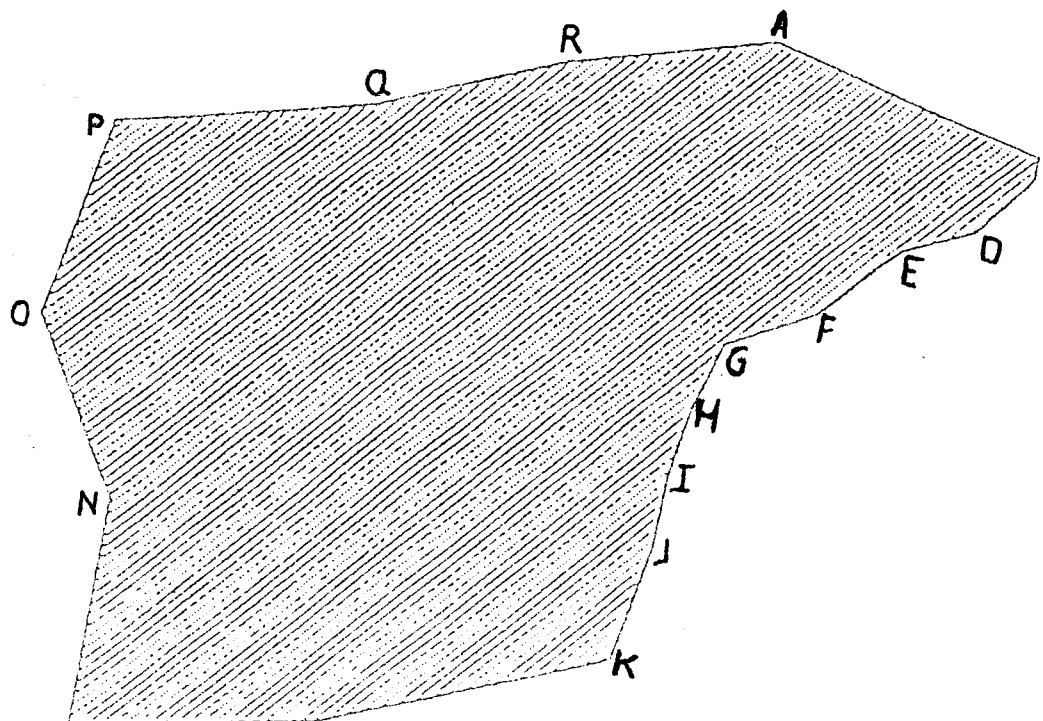

**AMENDMENT OF THE NAMIBIAN BROADCASTING REGULATIONS AND
INCREASE OF TELEVISION LICENCE FEES**

In accordance with section 27(1)(a) of the Namibian Broadcasting Act, Act No. 9 of 1991, the Minister of Information and Broadcasting wishes to:-

- (i) Amend regulation number 6 of the Namibian Broadcasting Regulations as promulgated under Government Notice number 118 as follows:

**DUPLICATES OF TELEVISION
LICENCE FEES**

6. A duplicate of a television licence may be issued to the holder of a television licence upon his or her written application and against payment of N\$20,00.

- (ii) Introduce new regulations aimed at increasing the television licence fees from the present N\$132-00 (one hundred and thirty two dollars) per set per annum to N\$180-00 (one hundred and eighty dollars) per set per annum for the coming licence year 1999/2000 with effect from 1 October 1999. SCHEDULE

1. Section 1 of the By-Law is amended by the insertion of the following definition:

"temporary advertisement" means any document, poster, leaflet, notice, drawing or prospectus circulated or displayed with the purpose to advertise or to give information relating, or to attract the public, to any place, public performance, article or merchandise, but does not include circulation by post or by registered newspaper."

2. The following paragraph is inserted after section 8(b):

"(c) or in any public place, circulate or cause to be circulated any temporary advertisement in the form of handbills, leaflets, pamphlets or other similar advertisement, except -

- (i) handbills, leaflets, pamphlets or other similar advertisement of educational, cultural or religious nature circulated by hand from person to person;
- (ii) handbills, leaflets, pamphlets or other similar advertisement placed loose in newspapers;

- (iii) handbills, leaflets, pamphlets or other similar advertisement placed within the premises of a business, firm, company or similar undertaking; or
- (iv) an advertisement affixed to facilities such as refuse receptacles, pillars or other objects provided for such purpose, or authorised by the Council; or
- (d) place or post in or on any motor vehicle a temporary advertisement in the form of handbills, leaflets, pamphlets or other similar advertisement."
