DESCRIPTION OF GEOGRAPHIC BOUNDARY:
BALYERWA CONSERVANCY

The boundary starts at 1, Boro co-ordinates S 18.33182 E 023.60964 which is the southern point on the boundary of the conservancy on the Mamili National Park northern cutline boundary, it then continues along the Wuparo conservancy western boundary in a northern direction through point 2, Nongozi GPS co-ordinates S 18.23291 E 023.62652, from point 2 it moves in north-westerly direction until point 3, Mankuni GPS co-ordinates S 18.16705 E 023.62512 on the Mudumu National Park southern cutline boundary. From this point it follows the Mudumu southern cutline boundary in a westerly direction and then moves in a south-westerly direction and then in a southerly direction until the Kwandu-Linyanti river. From this point it follows an easterly direction to the Mamili northern boundary cutline, then follows the Mamili cutline in an easterly direction until the point of beginning.

From point 1 the boundary follows an easterly direction until point 2 which is located on the border of Namibia and Botswana from where it follows the said border in a southerly direction to point 4. From point 4 it follows a north-westerly direction to the point of beginning.

**DESCRIPTION OF GEOGRAPHIC BOUNDARY:
KUNENE RIVER CONSERVANCY**

The boundary starts at the co-ordinates at point 1 on the Kunene River. From this point the boundary moves in a southerly direction to point 2, from which point it follows a south-westerly direction through point 3 and 4. The boundary then moves in a westerly direction to point 5 and 6. From point 6 the boundary moves in a northerly direction to point 7, from which point the boundary follows a westerly direction to point 8. From point 8 it follows a northern direction to point 9. The boundary follows a north-westerly direction through point 9 and 10 until point 11. From point 11 the boundary follows a north-eastern direction until point 12. From point 12 the boundary moves in a northern direction to point 13 on the Kunene River. The boundary then follows the Kunene River, where it co-insides with the boundary of Angola and Namibia in a south-eastern direction until the point of beginning.

**DESCRIPTION OF GEOGRAPHIC BOUNDARY:
SOBBE CONSERVANCY**

The boundary starts at Lisawana point 1, GPS co-ordinates S 17.82752 E 23.71114 which is the northern point on the boundary of the conservancy on the state forest southern cutline boundary and Trans-Capri highway. From this point the boundary moves in a south-easterly direction to point 2, from which point it moves in a southerly direction to Susuma point 3, GPS cord E 23.79996 S 18.13133. From point 3 the boundary turns and follows in the direction of the Malengenlenga conservancy boundary in a westerly direction to point 4, Namenda GPS cord E 23.71794 S 18.12251. From point 4 the boundary follows the Mudumu National Park eastern boundary in a northerly direction until the north-eastern corner of the park point 5 GPS E 23.71422 S 17.94261 and then turns in a westerly direction passing through point 6 and 7 GPS cords E 23.55452 S 17.93723 and E 23.54635 S 17.93252 that are on the northern park boundary, the boundary then continues to Kopano GPS cord E 23.54515 S 17.93242. From the last mentioned point the boundary moves in a northerly direction to point 8, Muhoto tree GPS cord E 23.54395 S 17.93038, the boundary then continues in a north-westerly direction through the old capri highway at point 9 GPS cord E 23.53980 S 17.90415, and continues in that direction to Mulombe tree (Baikela Plurijuga) point 10 GPS E 23.53065 S 17.87782 on the Trans-Capri highway. The boundary then follows the Trans-Capri highway to the point of beginning.

From point 3 it turns in a southerly direction to point 4. From point 4 it turns in a north-easterly direction to point 6, from which point it moves in a easterly direction to point 7 and then turns southerly to point 8. From point 8 it turns in a easterly direction to point 9 and then turns in a southerly direction to point 10 and follows in a westerly direction to point 11. From point 11 it moves in a southerly direction to point 12 from which point it continues in a southerly direction to point 13. From point 13 it turns in a north-westerly direction to point 14, from which point it continues to the point of beginning.

OHUNGU CONSERVANCY

The boundary starts at Ugab river 1, co-ordinates E 15.16200 S 20.72341, then moves in a eastern direction through Kwagaspan, GPS co-ordinates E 15.7341 S 20.78193 to Eoo the GPS co-ordinates E 15.40358 S 20.84982 and then turns sharply in a southern direction to Ovihungu Oviserandu GPS co-ordinates E 15. 41822 S 20.94776, from which point it follows a western direction to join the old cordon line GPS co-ordinates E 15.33463 S 21.09330 along the cordon line GPS co-ordinates E 15.20680 S 21.09900 and steps at Ombungu GPS co-ordinates E 15.06203 S 21.10141. From the last mentioned point the boundary turns in a eastern direction to Otumue GPS co-ordinates E 15.14198 S 21.0600. From point 10, 11 and 12 the boundary continues alongside Otjimboyo conservancy till Otjikakaneno GPS co-ordinates E 14.95721 S 20.87813, from which point it turns in a northern direction till the point of beginning.
