PROMULGATION OF ACT OF PARLIAMENT

The following Act which has been passed by the Parliament and signed by the President in terms of the Namibian Constitution is hereby published in terms of Article 56 of that Constitution.

No. 3 of 2006: Additional Appropriation Act, 2006.

Act No. 3, 2006 ADDITIONAL APPROPRIATION ACT, 2006**ACT**

To appropriate supplementary amounts of money to meet additional financial requirements of the State during the financial year ending 31 March 2007.

(Signed by the President on 22 December 2006)

BE IT ENACTED by the Parliament of the Republic of Namibia as follows:

Appropriation of amounts of money for financial requirements of State

1. Subject to the State Finance Act, 1991 (Act No. 31 of 1991), the amounts of money shown in the Schedule are appropriated as a charge to the State Revenue Fund for additional financial requirements of the State during the financial year ending 31 March 2007.

Short title

2. This Act is called the Additional Appropriation Act, 2006.
